 - 8.I. Rules Of Procedure Ordinance For Council Meetings 1st Reading Background:

On September 18th, Mayor Hallman initiated a discussion on implementing rules for public comments and presentations for Council meetings. The City Attorney has drafted the attached ordinance to encompass these rules and other pertinent procedures for meetings.

8.II. Consideration Of A Text Amendment To The Restaurant Ordinance - 1st Reading **Background:**

As currently written, the City of Hapeville Municipal Code has restricted restaurants in most zoning codes to full-service or to those that exclusively seat patrons. This limited definition provides little opportunity for "fast casual" restaurants where patrons are served at the counter and seat themselves or take their meals to go. In an effort to avoid, "fast food row", the Code also restricts drive-through restaurants and does not provide direction should there be an opportunity to accommodate a drive-through window. Given the shifting nature of self-service, with and without drive-throughs, the proposed ordinance allows for simplification of the restaurant definition to include a wide array of restaurants while differentiating for simple carry-out and drive-through restaurants which may follow the intent of the various zoning districts regarding pedestrian-oriented development.

The City Planning Commission considered this item on October 9, 2018 and recommended the Mayor and Council approve the proposed text amendment. Staff supported their recommendation.

8.III. Human Trafficking Notice Ordinance - 1st Reading Background:

At the October 2nd Council Session, Mayor and Council supported the idea of moving forward with the "Hang the Sign" challenge to join the fight against Human Trafficking. Attached is an ordinance providing for the compliance with state human trafficking notice requirements. 8.IV. Consideration And Action To Adjust The 2018 Property Tax Millage Rate Background:

At the October 2, 2018 Council meeting, Mayor and Council voted the tax millage rate of 16.44 mills and to change the Homestead Exemption to \$12,000 from \$10,000. As a change in the Homestead Exemption must be enacted through the Georgia General Assembly and a citizen vote, the Mayor and Council are re-visiting the millage rate for 2018 property taxes to memorialize their intention and the procedure to change the homestead exemption.

8.V. Consideration And Action On Main Street Board Request To Work Directly With Outfront Media On Behalf Of The City Of Hapeville, In Accordance With The Terms Of The Settlement.

Background:

Per the settlement agreement between the City of Hapeville, Georgia, and Outfront Media LLC, executed on February 21st, 2015, the City of Hapeville has access to one spot, six times per year for a period of two weeks at a time, for specific uses. Currently this space is not being utilized and the Hapeville Main Street Board would like permission to work directly with Outfront Media, on behalf of the City of Hapeville, in accordance with the terms of the settlement. The Main Street Board's intent is to insert the already existing "Hapeville, A home for the arts" billboard into the current rotation and as the default marketing message for the billboards, as well as updating and changing billboards in the future.

8.VI. Discussion Initiated By Councilman Horsley On Finding The Flint Resolution And Watershed Policy

Background:

Councilman Horsley would like to initiate a discussion on having a resolution to support the Initiative referred to as 'Finding the Flint'. Finding the Flint is a big vision for rediscovering and restoring the Flint River headwaters in the Atlanta Airport area.

Additionally, before the close of Fiscal Year 2019, the City of Hapeville will begin discussion on updating the City's watershed policy, incorporating tenants from Finding the Flint, with the assistance of the Atlanta Regional Commission. This includes incorporating standards from the most recent policy 'Blue Book' related to watershed policy.

8.VII. Discussion Initiated By Councilman Horsley On The Addition Of Tattoo Shops To Conditional Usage In Zoning

Background:

The purpose of this discussion is to gauge Mayor and Council's thoughts on zoning ordinance changes that would permit 1) Tattoo Parlors into the Permitted Uses section, which would allow them anywhere in UV, or 2) to the Conditional Uses, which would require them to get approval on a case by case basis.

Per Councilman Horsley's review, it appears that the current zoning ordinances tattoo parlors are non-permitted uses in V Zone, SEC. 93-11.1-3 (4), UV Zone, SEC. 93-11.2-4(4), and DD Zone, SEC. 93-19-3 (B)(3). It appears that the available spaces are in the UV zones.

8.VIII. Discussion Initiated By Councilman Adams Concerning Optotraffic Innovative Traffic Safety Solutions

Councilman Adams is initiating a discussion regarding the desired review of the use of Optotraffic LLC's product solution and service to reach traffic safety goals.

8.IX. Discussion Initiated By Councilman Adams Related To The City Of Hapeville Possibly Becoming/Establishing A Partner(Ship) In Education (PIE) Amoung Tri-Cities, Hapeville Charter Middle And Career Academy, Hapeville Elementary

Background:

Partners in Education (PIE), originally known as "Adopt-A-School," purpose is to improve education by stimulating meaningful business and community involvement in public schools. Through individual partnership with businesses, professional organizations, churches, civic clubs and military units, schools have been able to tap into resources that helped meet and exceed the individual needs of their student body, provide excellent educational programming, and recognize academic

achievement. PIE connects students, teachers, and administrators with business resources to increase the quality of education for our future leaders.

Councilman Adams recommends that the City of Hapeville establishes a PIE program to partner with Tri-Cities High School, Hapeville Charter Middle School and Career Academy, and Hapeville Elementary School to exchange resources, services, and other forms of support. The collaborative relationship could benefit both partners, but ultimately improves educational opportunities for children. Additionally, a more involved community aids in higher performing schools; thus, having a positive correlation on a city's viability and economic growth potential.

8.X. Discussion Initiated By Councilman Alexander On Home Brewing Competition Ordinance

Background:

Councilman Alexander will initiate a discussion to have a possible ordinance that would allow for home brewing competitions. Attached is a home brewing special events ordinance from Avondale Estates that can be reviewed by legal and modified as necessary to comply with Hapeville's existing code, and review what changes, if any, would need to be made to the city's ordinances to allow for home brewing competitions.

Microbrewing has become more popular in the south. Councilman Alexander feels that adjusting the code to allow for brewing would make Hapeville an ideal destination for local and regional competitions.

8.XI. Discussion Initiated By Councilman Alexander On LED Safety Crossing Lights For Highly Trafficked School Routes
