6 **A RESOLUTION REQUESTING THE GENERAL ASSEMBLY TO CREATE A**  
7 **PARKING AUTHORITY FOR THE CITY OF HAPEVILLE; TO AUTHORIZE THE**  
8 **MAYOR TO SIGN ANY AND ALL DOCUMENTS NECESSARY TO EFFECTUATE**  
9 **THIS RESOLUTION; TO AUTHORIZE THE CITY ATTORNEY TO PREPARE ANY**  
10 **AND ALL DOCUMENTS NECESSARY TO EFFECTUATE THIS RESOLUTION; TO**  
11 **AUTHORIZE THE CITY CLERK TO ATTEST SIGNATURES AND AFFIX THE**  
12 **OFFICIAL SEAL OF THE CITY, AS NECESSARY; TO REPEAL INCONSISTENT**  
13 **RESOLUTIONS; TO PROVIDE FOR AN EFFECTIVE DATE; AND FOR OTHER**  
14 **PURPOSES**

16 **W I T N E S S E T H :**

18 **WHEREAS**, the City of Hapeville (“City”) is a municipal corporation duly organized  
19 and existing under the laws of the State of Georgia; and  
20

21 **WHEREAS**, the City wishes to request that the Representative and Senator representing  
22 the City of Hapeville introduce to the General Assembly legislation allowing for the creation of a  
23 Parking Authority for the City of Hapeville; and  
24

25 **WHEREAS**, the Mayor and Council of the City of Hapeville, in the exercise of their  
26 sound judgment and discretion, after giving thorough consideration to all the implications  
27 involved, and keeping in mind the public interest and welfare of the citizens of the City, have  
28 determined that creating a Parking Authority would benefit the citizens of the City.  
29

30 **THEREFORE, IT IS NOW RESOLVED BY THE CITY COUNCIL OF THE**  
31 **CITY OF HAPEVILLE, GEORGIA, AS FOLLOWS:**  
32

33 1. **Incorporation of Pre-Ambles.** The pre-ambles are incorporated herein as fully set  
34 forth above.  
35

36 2. **Creation of Parking Authority.** The Hapeville City Council wishes to request  
37 that the Representative and Senator representing the municipal limits of the City of Hapeville  
38 introduce for consideration by the General Assembly local legislation allowing for the creation  
39 of the “City of Hapeville Parking Authority” and to authorize such Authority all necessary and  
40 proper powers to effectively execute its duties.  
41

42 3. **Authorization for Mayor.** That the Hapeville City Council hereby authorizes  
43 the Mayor to execute any and all documents necessary to create said parking authority. A copy  
44 of said documents shall be filed with the City Clerk.  
45

46 4. **Attestation.** That the Hapeville City Council hereby authorizes the City Clerk or  
47 Assistant City Clerk to attest the signature of the Mayor appearing on the documents, to affix the  
48 official seal of the City thereto as necessary to effectuate this Resolution, and to place this  
49 Resolution and an executed copy of all documents among the minutes or official records of the  
50 City for future reference.

51  
52 5. **Authorization for Attorney.** That the Hapeville City Council hereby authorizes  
53 the City Attorney to approve this Resolution as to its form and review any and all documents  
54 necessary to create said parking authority for the City of Hapeville and to ensure all documents  
55 conform to state law.

56  
57 6. **Severability.** To the extent any portion of this Resolution is declared to be  
58 invalid, unenforceable, or nonbinding, that shall not affect the remaining portions of this  
59 Resolution.

60  
61 7. **Repeal of Conflicting Provisions.** All City resolutions are hereby repealed to  
62 the extent they are inconsistent with this Resolution.

63  
64 8. **Effective Date.** This Resolution shall take effect immediately.
