- Applicants submitting an open records request from former places of businesses;
- Applicants visiting Homeowner's Association meetings

- Requirement of 51% food sells, specific hours to serve meals, sale of distilled spirits must sold to one individual and not by the bottles, 75/25 occupancy rule, private clubs, displaying of alcohol certificate and other inspections cert., ability to see inside establishment at the establishment, training for establishments. The Board references the memo that City Manager William Whitson sent to the Board.
- Visibility 5-2-3 and 5-6-6(a) – cannot have tinted windows must have clear view into the window. Night light issue applies to all businesses
- Training 5-3-2(i)(2) training specifically be done by ARB cost the city nothing takes no time from any city employee
- Training city employees on the Code.
- Assignment of form numbers and date originally adopted and then providing revision date
- Monthly and quarterly reports to the ARB, want envelope attached to the return.
