IV. Applications

1) 3408 Orchard Street - Ryan Mooney attending

John Stalvey made a motion to approve the application with the following statements:

- a) Design exception for the 10-foot column spacing for design aesthetic
- b) Applicant must go before the Board of Appeals for the setback variance and the Committee recommends approval.
- c) Applicant agrees to follow the recommendations defined in the Planner's Report

Rick Ferrero second the motion and it passed 5-0.

2) 2102 Argo Drive - Aldo Gutierrez attending

Karl Dufresne made a motion to approve the application as applied. John Stalvey seconded the motion and it passed 5-0.

- a) Modify all windows to be 1 over 1.

Brian Gregory made a motion to approve the application as applied with the following requirements:

- a) On front elevation, the first story windows shall be 3 over 1
- b) On front elevation, the second story window to be 2 over 1 (style D) (replace MBRA window with D) placed to create symmetry with the existing style D window in the Master Bathroom.
- c) Add an A style window (ingress/egress) on the right-side elevation for the MBR (across from the closet)
- d) Modify porch roof to be a shed roof (remove hips)

Karl Dufresne seconded the motion and it passed 4-0.
