- 1. Call to Order: Mayor Hallman called the work session to order at 7:05pm at 700 Doug Davis Drive, Hapeville, GA 30354.

Mayor Hallman thanked everyone for coming out and also congratulated Alderman Rast on the birth of his first grandchild.

- 6.I Recognition of Service Awards by Mayor Hallman Mayor Hallman recognized James Carroll III, Lemuel Eubanks, Michael Hinson, Tonya Hutson, and Calvin Westbrooks for their years of service.

7. PUBLIC HEARING

7.1 Consideration and Action to Set the Millage at 16.44

Mayor Hallman opened the Public Hearing to hear from staff, public and Council. Mr. Young stated that it was found that the total digest should bill out at 4.2 million with property that is exempt; \$150,000

will be taken off. If we keep the 16.44 mills and don't do a water sewer transfer, we are actually budgeting to break even for the general fund. This is a positive thing. Public comments were made by Frank Cranford, Joseph Shorter, and Brendan Cornwell.

Councilman Horsley said he is interested in a 15.94 reduction which is about \$144,000. Councilman Alexander asked for clarification on whether the intent is not to make the water sewer transfer. She said she can see why the increase in expenses would occur. Councilman Adams stated they've haven't been able to give raises to EMS and recruit officers. He doesn't think we should cut the millage rate or drastically cut the homestead exemption. Alderman Rast supports leaving the millage rate as is; there are too many unknowns. Mayor Hallman's said that one assumption being made is that the tax digest is going to remain the same, but he said he can guarantee that the digest will not remain the same. We have ongoing pensions that we have to meet, increasing healthcare cost and other needs that have gone unfunded. The community must be willing to pay for the level of service of service we receive. Mayor Hallman closed the public hearing.

MOTION: Alderman Rast made a motion to adopt millage as 16.44 going forward. Motion died due to lack of second.

MOTION: Councilman Adams made a motion to keep millage rate at 16.44 and increase homestead exemption from 10 to 12, Alderman Rast seconded. Discussion: Mr. Young calculated the numbers and said this will drop us about \$24,000 in revenue. Vote 2-2. Mayor Hallman voted in the affirmative to support the motion.

7.II Consideration and Action to Amend the A-D Zone (Arts Overlay District) – 2nd Reading Mayor Hallman opened the Public Hearing to hear comments from staff and the public. Staff did not make any comments. Larry Martin commented during the public comment section. Councilman Alexander asked about the existing ordinance. Mayor Hallman said we have to be careful with limitation of free speech, but he is not opposed at looking at stricter guidelines, but it is a slippery slope. He added that they have to look at the genesis of why they are doing this. It's primarily led by Maker's Space. Mayor Hallman closed the hearing.

MOTION: Councilman Horsley made a motion to approve, Councilman Alexander seconded. Motion carried 4-0
