6.I Consideration and Action to Approve the 2019 Meeting Schedule

MOTION: Mayor Hallman made a motion to move July 4 date to July 11, Susan Bailey seconded. Motion carried 7-0. Mayor Hallman made a motion to adopt the meeting schedule with change to July 11, Vice Chairman Morrison seconded. Motion carried 7-0.

6.II Update on Remediation Status of 748 Virginia Avenue

David Burt gave an update stating that the state has a new risk assessment that they want to run through. This is a good thing. It looks like the its not contaminating water and not spreading out, and it might be fine to just leave it alone. A new proposal has been created to add one more well across the street and monitor quarterly for a year. Mr. Burt handed out the proposal to the members in attendance. Over the next year, to do the work it'll cost \$49,225. Mr. Burt said that we know we can't sell it because we're on the hook for this until the state finally signs off stating we're good. However, if the building is renovated it can be used during this period. It is recommended to do a soil vapor study under the slab and then put a barrier down which is an additional cost of \$4,800.

Mr. Burt stated that the Atlanta Printmakers still need to move. They would like to come to Hapeville. They have the museum and classes. It'll be something active that would bring a lot of people in. Some of their board members aren't sold, so they're coming to see the location on Saturday. Mr. Burt said that hotel/motel tax could possibly be used to renovate the building; however, this would need to be confirmed.

Chairman Bradberry stated that the reason this was brought up is to see whether the Authority would even consider it. It was discussed at the TPD Committee meeting.

The Authority discussed the issue of semi-trucks parking at the location. Chairman Bradberry said she would talk to Lee Sudduth about the situation to see what could be done. Mayor Hallman said "no parking" signs need to be posted.

6.III Consideration and Action on Expenditure for Cap-B Template and Corrective Actions and Sub-Slab Vapor Sampling for 748 Virginia Avenue

MOTION: J. Allen Poole made a motion to authorize the expenditure as proposed for \$49,225 and authorize \$4,800 for the soil vapor study for 748 Virginia Avenue, John Stalvey seconded. Motion carried 7-0.

6.IV Consideration and Action on Renovation of Gas Station Building at 748 Virginia Avenue Using Potential TPD Funds

MOTION: J. Allen Poole made a motion to ask the City for TPD funding to renovate the building to lease to the Atlanta Printmakers pending TPD eligibility, John Stalvey seconded. Motion carried 7-0.

MOTION: Susan Bailey made a motion to spend funds to secure property so no one can get on it to park stop parking and to place "no parking" signs, John Stalvey seconded. Motion carried 7-0.

7. Economic Development Update

David Burt stated that Willingham had to extend the closing because they are still going through the City process to get their permit. The contract allowed for one extension. Mr. Burt said that they'll break ground as soon as they close.
