A RESOLUTION PROVIDING AUTHORITY FOR THE CITY OF HAPEVILLE 4 TRAFFIC ENGINEER TO ESTABLISH A SCHOOL ZONE FOR GATEWAY 5 CHRISTIAN ACADEMY; TO AUTHORIZE THE MAYOR TO SIGN ANY AND ALL 6 DOCUMENTS NECESSARY TO EFFECTUATE THIS RESOLUTION; TO AUTHORIZE 7 THE CITY CLERK TO ATTEST SIGNATURES AND AFFIX THE OFFICIAL SEAL OF 8 THE CITY, AS NECESSARY; TO REPEAL INCONSISTENT RESOLUTIONS; TO 9 PROVIDE FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WITNESSETH:

WHEREAS, the City of Hapeville ("City") is a municipal corporation duly organized and existing under the laws of the State of Georgia; and

WHEREAS, the Mayor and Council of the City of Hapeville find that for safety and general welfare of residents, including students, a City school zone needs to be established on College Street near Gateway Christian Academy; and

WHEREAS, the intent of this resolution is to provide for the City of Hapeville Traffic Engineer authority to provide for a City school zone distinction for the Gateway Christian Academy; and

WHEREAS, the Mayor and Council of the City of Hapeville, in the exercise of their sound judgment and discretion, after giving thorough consideration to all the implications involved, and keeping in mind the public interest and welfare of the citizens of the City, have determined that they would like to establish a City "school zone" distinction on College Street for Gateway Christian Academy.
