During the month of March, the Department conducted 26 Annual Inspections, 2 site inspections, 9 new construction site visits, 10 plan reviews for the Planning Commission, 1 fire sprinkler plan review, 49 pre-fire plans, issued 5 Business licenses/Certificates of occupancy, 3 complaint investigation, 2 plan reviews for new construction, 1 alcohol license inspection, 5 certificate completion inspections (smoke detectors replacement) and 65 blood pressure checks at the Senior Center. Also, the following in house trainings were completed by our personnel: Web Based Target Solutions Training, National Incident Management Systems (NIMS 400) training, Officers Administrative Functions, New Hires Training, Aerial Training, and StaffHub Training. The Training Division Chief completed and submitted the 2017 CARES report to Emory University, and continues writing our medical protocols. He also completed the Health Insurance Portability and Accountability Act (HIPAA) and EMS reporting policies to be implemented for the department. Members of the Department also taught, attended and/or participated in the following off-site trainings and events: Response to Terrorism in Georgia class at the Fire Academy, Handling Flammable and Combustible Liquids Incidents, Disaster Recovery Programs Operations: Information & Documentation, Live Fire Training, and Leadership Train the Trainer course. The Department hosted the monthly South Fulton Chief's meeting. Also, students from the Corner Pre – School visited station 1 for a tour and class on fire safety and prevention.

Between March 1, 2018 and March 29, 2018 there were (457) calls for service. There were (0) Assaults, (2) Burglaries, (3) Robberies, (52) Larcenies; including 36 Entering Autos, 3 Stolen

Vehicles and 13 Thefts. The Department recovered (11) stolen vehicles. The Department made 41 arrests. Average Response time was 1min 47secs.

The Department issued 371 citations to include parking, traffic and general copies.

The E911 Center processed 3,257 calls.

Department Personnel continued to receive daily roll call and in-service training on topics such as Use of Deadly Force, Domestic Violence Investigations, Dealing with the Mentally Ill & People with a Diminished Capacity, Evidence Collection & Preservation, Mental & Emotional Wellness, Legal Updates, and the HPD's Standard Operating Procedures.

The Detective Division reviewed (48) cases, assigned (38) cases for investigation, and closed (30) cases. (2) Cases were closed with arrest warrants and (1) by CID arrest. The Detective Division obtained (10) warrants and responded to (12) crime scenes for investigation.

Code Enforcement: Code Enforcement handled (133) new calls for service. During these calls, the unit documented (7) animal incidents, (5) parking in grass, (32) tall grass & weeds, (4) permit issues, (17) outside storage, (48) littering or pollution problems, (11) property maintenance- exterior, and (9) other code compliance issues. The unit closed (103) cases and issued (9) citations.

Abatements: The current properties that are under abatements are as follow: 3 Woodrow lot (between Wheeler and N. Fulton Avenue), 330 Mount Zion Road, 370 Woodrow Avenue, 3001 Dogwood Drive, 3309 North Fulton Avenue, and 3227 Jackson Street.

Staff continued to support and meet with Hannah Palmer, Coordinator for the Finding the Flint Project. Staff attended a Finding the Flint Working Group meeting on Tuesday, March 13th and will attend the next meeting which is scheduled on April 10th.

Staff successfully completed the report data sheets for the Local Update of Census Addresses (LUCA) program. LUCA is an important component of an accurate 2020 Census count, which is used to reapportion Federal House and Senate seats and helps the federal government annually allocate more than \$400 billion across 26 federal agencies for tribal, state, and local government programs and services for the next ten years. Staff began working with ARC in November 2017 to help ensure that the City of Hapeville has an as accurate a count as possible so to maximize the amount of federal dollars that will flow into the region based on the 2020 Census. Staff received the census data reports in March 2018 and completed the requested data updates and we are awaiting final confirmation by the Census Bureau.

The Department issued a call to select an artist to transform the ordinary crosswalks on King Arnold Street/Clair Drive and North Fulton Avenue/Scout Street to kid friendly crosswalks. Applications are due by Thursday, April 12th.
