The Department had 34 fire inspections, 1 plan review, 14 pre-fire plans, 15 consultations, 80 blood pressure checks, and 100 hours of Firefighters on patrol. The Department completed a total of 830 hours of training. Two members attended the Fire & Life Safety Educator Course at the Georgia Public Safety Training Center (GPSTC) and the Firefighters' weekend at the same location during which they were trained in the handling of flammable liquids. 21 members of the Department conducted live burn training and 8 conducted a Rapid Egress from Hostile Structures exercise. Two officers/investigators attended the Spring Arson Seminar in McDonough, GA. All members have been familiarized and trained on the utilization of the newly acquired Scott's air-packs, face masks and cylinders in order to put the equipment in service. Approximately 40 children attended career day at the Senior Center, in which several members of the Department explained to them what it is like to be a firefighter. One member of the Department read to a kindergarten group during the Hapeville Elementary Read-A-Thon.

In the month of March, the Police Department answered (371) calls for service. There was (4) reports of Assault, (2) Burglaries, (1) Robbery, (10) Auto Thefts, and (27) Other Larcenies.

The Department closed (49) cases with arrests and issued (22) additional arrest warrants. There were (310) citations issued, (239) Traffic, (54) General Citations and (17) Parking. An average (2:50) minute response time to calls.

The Detective Division received (78) new cases, obtained (22) Felony arrest warrants, and cleared (1) case with arrest. The unit currently has (42) active or assigned cases and they closed (80) cases. Cases cleared by warrants included (3) armed robberies, (1) assault, (1) auto theft, (3) frauds and (1) burglary.

Department Personnel continue to receive daily roll-call and in-service training on topics such as Legal Reviews, Suspicious Person calls, Security & Integrity, Pursuits, Standard Operating Procedure training, Pistol/Shotgun Instructor Training, Evidence Presentation Course, and Glock Inc. Armorer's certification.

The Department underwent a mandatory audit of its State of Georgia Law Enforcement Certification and was given a recommendation from the Audit Team!

Code Enforcement handled (115) new calls for service, of which (30) were animal incidents and (85) were code compliance issues. The unit closed (64) active cases, issued (4) citations and delivered (1) recovered animal to the Fulton County Animal Control Facility.

New Business:

Community Choices Application for Implementation Assistance 2013

Hapeville plans to modernize its zoning ordinance, much of which was adopted in 1981. The project proposed for Community Choices Program assistance consists of generating Form Based Code districts for strategic locations. These locations are poised for growth, including commercial properties near the Virginia Park neighborhood and Porsche's property. These strategic locations are ripe for development in land uses consistent with the "Aerotropolis" themes being promoted by area planners. An infill housing ordinance project that will serve to protect the historic character and scale of Hapeville neighborhoods is also proposed.

Executive Suites Hotels in the U-V Zone?

On March 19, Mayor and Council directed city planner to research standards concerning possible introduction of "executive suites" hotels in the U-V Zone, particularly to complement the Porsche development. Such standards as are being drafted are intended to ensure high quality development and will be presented to Mayor and Council following vetting by City staff.
